TALKING POINTS TO USE WHEN LOBBYING ELECTED OFFICIALS

- 1) **Planned Parenthood sells aborted baby body parts. If politicians, elected officials, and candidates for office do not publicly denounce Planned Parenthood and publicly call for the defunding of Planned Parenthood, they are complicit in the abortion organization's practices.**
 - a. In Planned Parenthood's world, babies are worth more dead than alive. The humanity of the child is disregarded in the name of profit. Any politician who supports Planned Parenthood supports this deranged view of preborn babies.
- 2) **Planned Parenthood alters the abortion method in order to get intact body parts to sell – possibly making the procedure even riskier for women and breaking federal law.**
 - a. Partial-birth abortion is illegal in this nation and the abortion methods that the Planned Parenthood abortionist described in detail is a partial-birth abortion.
 - b. Partial-birth abortion is wildly unpopular in America. Does your elected official support partial-birth abortion? If they received money from Planned Parenthood, will they give it back considering what has come to light in these videos?
- 3) **Planned Parenthood supports and covers up baby parts sales at the highest levels of their organization.**
 - a. Cecile Richards said the abortionist caught undercover in the first video is “amazing.” Any elected official supporting Planned Parenthood supports Cecile Richards, who knew that her organization was selling the body parts of aborted babies.
- 4) **Planned Parenthood needs to be investigated and prosecuted to the fullest extent of the law and defunded immediately. We call on every presidential candidate to pledge to defund Planned Parenthood.**
 - Planned Parenthood is a government contractor that gets over \$500 million a year in government money. The organization has been caught covering up [statutory rape](#),
