

- [¥] Empower pro-life student leaders through our *Missionary for Life Internship*, *Wilberforce Leadership Fellowship*, and *Thaddeus Stevens Leadership Fellowship*.
- [¥] Promote pro-life student activity to other local, student, and national groups through national coalition efforts.

OUR HISTORY

Students for Life of America (SFLA) began in the late 1970s as CAmPUS and was later renamed American Collegians for Life (ACL) and re-organized as a 501c3 organization in 1988. From 1988 to 2006, ACL was a student-run volunteer organization that hosted an annual conference, developed a resource website, and produced a quarterly publication.

In 2006, ACL changed its name to Students for Life of America (SFLA) and opened its first national headquarters in Arlington, VA. At this time, SFLA hired a professional staff and launched its historic Pro-Life Field Program.

Since 2006, SFLA has helped to start more than 650 new student pro-life organizations and has trained hundreds of previously existing student pro-life groups. In the past 7 years, SFLA has trained tens of thousands of pro-lifers at its national and regional conferences and one-on-one campus trainings and saved the lives of countless preborn children. To testify to the growth of SFLA, one needs to look no further than the SFLA National Conference. In 2007, the Students for Life of America National Conference had 450 registered attendees. The 2013 SFLA National Conference sold out for the 4th year in a row, with over 2,000 registered attendees.

In addition to starting and training student pro-life groups, SFLA has become a major player in the national pro-life movement through leading and participating in national coalition efforts such as *De-Fund Planned Parenthood*, *Stop the Abortion Mandate, Stop Carhart*, and *Not at BC*.

A MESSAGE FROM OUR PRESIDENT

Dear Friends,

To abolish abortion in America, we know we must change our culture, and the most effective way to change our culture is to change this rising generation. We must instill in this generation pro-life values in high school and college when they are first forming their views about sex and abortion, and when the abortion industry targets them the most.

In the past, social and political movements have relied on youth to change the culture of our nation. Recent examples in American history are the civil rights movement, the anti-Vietnam protests, and the antismoking campaigns of the 1980s and 1990s.

Further, recent studies on the creation of social movement activists have found that the making of a life-



long activist is a multi-staged process that must take place during a "time of change" in a person's life. In addition, an activist is only developed after initial contact and activism within the movement -- after a friend invites the soon-to-be activist along to a meeting or event. These factors make college and high school the ideal environments for creating the grassroots, pro-life army our nation needs.

Because students value information given to them by their peers more than that given to them by their parents or other authorities, student activism and peer-to-peer education, is the greatest opportunity our movement has for changing hearts and minds, saving lives, and abolishing abortion in this lifetime.

And Students for Life of America (SFLA) is equipped to do just that. We meet pro-life students where they are, in school and online, and we build relationships with them - inspiring stand, teaching them effective leadership techniques and strategies, and them with all the resources they need to be candles of truth on their campus. We are the only organization like this across the nation.

In the past 7 years, SFLA has experienced tremendous growth, from 181 campus groups to over 750 today, and the demand is out there for more! I hope after reading through this report of our 2012-2013 school year you will be as excited as I am for what is to come for our movement and nation and will consider partnering with us.



OUR FIELD PROGRAM

Students for Life's one-of-a-kind Field Program has played a pivotal role in the growth and success of the organization over the last 7 years, taking us from 181 student groups when we started full-time in 2006 to the 759 we work with today.

Our Field Program is comprised of a national team which manages and supports our student groups across the country. We build personal relationships with student leaders and group members through our full-time Regional Coordinators who work in specific regions throughout the academic year with the groups. The Regional Coordinators receive training so that they excel at empowering campus groups. They support these groups to help them educate their peers about abortion and provide resources to pregnant and parenting students on campus. Additionally, the Regional Coordinators build relationships with local pro-life organizations.


By having dedicated team members in specific regions, we are able to provide personalized support for our student leaders and groups, which in turn leads to the creation of effective, sustainable campus pro-life organizations.

During the 2012-2013 school year, SFLA had 4 full-time Regional Coordinators in the field, covering 14 states. For the 2013-2014 school year, Students for Life will have 6 Regional Coordinators, covering 19 states.




EVENT IN A BOX

HIGH SCHOOL & HOME SCHOOL INITIATIVE


In 2013, SFLA launched a full-time initiative dedicated to equipping high school and home school students to start pro-life groups in their schools, churches, and communities. While working almost exclusively with college groups since 2006, the Students for Life team discovered that students in high school were desperate for our resources and trainings. In addition, we know that along with college-aged women Planned Parenthood targets high school girls and boys with their anti-abstinence, pro-abortion messages.

With this initiative, we equip high school pro-life leaders for the unique activism that happens in high school. We offer them the programs and resources that fit into their world, use their language, and are appropriate for the interest, needs, and age.

Our high school outreach clearly meets a previously unmet need.

Why We Love Working with Teens

When asked if she was traveling from Wisconsin to the March for Life in Washington, D.C., Cassidy, one of our 15 year-old leaders, remarked, "but I was just thinking... if abortion becomes illegal, they won't have a March next year..."

PREGNANT ON CAMPUS INITIATIVE

As we strive to make abortion unthinkable, educating and activating students nationwide, our team at Students for Life understands that we must meet young parents where they are, in crisis, and provide them with the resources they need to chose Life.

In September 2011, SFLA's *Pregnant on Campus Initiative* was launched to assist our pro-life student groups in how to reach students facing a crisis pregnancy with tangible support and resources. Through effective marketing and committed outreach, our pro-life groups are able to remove the perception that a girl must choose between her education and the life of her child.

The first step for student groups participating in the *Pregnant on Campus Initiativ*e is simply promoting awareness on campus. Without knowing about their resources prior to an unexpected pregnancy, young girls are trapped by a poor perception of their options and available resources, rushing them into the grips of the abortionist.

The second step is for groups to work on campus through their organizations, community pro-life contacts, and school administrations to provide the resources that are missing, which could help scared, pregnant students choose Life.

On many campuses, there is stunning lack of resources for pregnant and parenting students. In surveys conducted of college students by *Students for Life of America* and *Feminists for Life*,

- 46% said there was no housing on campus for parenting students.
- 45% said their college did not offer on-campus childcare
- 62% said they had not seen diaper-changing stations in restrooms
- 77% said there was no private place for women to nurse or pump breast milk

A World of Possibilities...

Pregnant on Campus Initiative participants are the problem solvers of this generation. When they envision a world without abortion, they envision a world where every mother can achieve her educational and career goals without compromising her child's life and care -- where a man can be both a student and a father. Through the *Pregnant on Campus Initiative*, pro-life students are bringing this vision into reality by reducing the barriers and stresses that may challenge a pregnant or parenting student. While Planned Parenthood boasts of its newest motto, "Care. No matter What," our pro-life students have defined true care for women, children, and families.

Remember, Babies Who Are Saved Grow Up

By Julia Pritchett, Former Students for Life Missionary for Life & Wilberforce Fellow "The day before I left New York City I was able to make a special trip to see a little boy God used me to help rescue from abortion. He opened the apartment door and stared at me with these big eyes. Even though the last time I was with him he was in the womb, it was like he knew me. He sat on my lap and held my hand and kissed me on the cheek. Sometimes it is hard to connect the dots in our minds when we are attempting to save human lives from abortion. It's hard to imagine the babies as older people since we have no idea yet who God made them to be; we just know they shouldn't be killed. Experiencing this precious child of God lavish me with love was incredible."

Students for Life Northeast Regional Coordinator Phil Eddy had many blessings during an otherwise tense time: the 2012 election season. In one night, he talked to two women who decided to seek help at Pregnancy Resource Centers, rather than death at abortion facilities. One woman, with an abortion scheduled in only a few days, saw an online, Facebook post from Phil about the abortion facility she planned to visit. His sister had gone to the same facility and was told that her baby was a "leech." Phil posted a picture of the socalled "leech" - now three years old. This picture inspired her to find out how to help her own baby. Then, a short time later, Phil won a young man over to the pro-life view. The young man then convinced his girlfriend, who was pregnant at the time, to keep their baby by offering his love and support.

Grove City College ByPeter Foster,

Member of GC Life Advocates "Today I was able to be a part of something incredible. While praying outside an abortion clinic, a woman came up to us and thanked us. She had an appointment for an abortion scheduled at Planned Parenthood, and, as she drove to the clinic, she prayed to God for a sign. The group of us praying outside the clinic was that sign, she said, and she wants to keep her baby and do anything she can to encourage other women to keep their children!"

University of Richmond

In February, Sarah Maher, SFLA's Capital Area Regional Coordinator, visited the University of Richmond Spiders for Life to train them in sidewalk counseling. They went out that same weekend to pray and witness at their local abortion facility, with a sign that read, "Think you can't afford your baby?" and listed the information for a local Pregnancy Help Center.

A young couple passed the group, pointing to the sign, but went inside. The students' hearts sank, thinking they hadn't reached the couple. However, thirty minutes later, the couple walked out and told the group that they had decided against the abortion. Because they had seen the young people praying for them, they were going to call the Pregnancy Help Center. The group was filled with joy and praised

St. Cloud State University When members of SCSU for Life went to sidewalk counsel this May, they were feeling discouraged, doubting that their presence and actions would have any impact. At the abortion facility that day though, they learned that their presence had helped a young woman to choose life!

Saint Mary's University

Rattlers for Life at Saint Mary's learned this winter that a young woman chose life after seeing their group sidewalk counsel in front of an abortion facility!

Lane Community College

On the anniversary of *Roe v. Wade*, LCC Students for Life tabled on their campus. Sierra, president of the group, sent us the story of one young woman who stopped to hold a baby model:

"When she held that tiny baby in her hands, she broke down crying...She pulled me aside from the others who were gathering around the table and told me that when she found out vesterday that she was pregnant. The news had turned her world upside down. She felt alone, scared, and helpless. She told me that she thought abortion was her only way out. But now she could see that there is an amazing baby growing inside of her, and, when she finally did leave the table, she left filled with excitement and anticipation, with an arm full of literature and resources. She started to walk away, but then she turned around and came back for a moment. She started crying again and said to us: 'Thank you girls for what you're doing.' Then she hugged me, and I comforted her as tears streamed down her face."

University of Alabama-Birmingham

During our April Planned Parenthood Project Tour, a pregnant student approached our display at the University of Alabama and spoke with members of the Students for Life group about how the display helped her make the final decision for Life!



Controversy on Campus...

Oftentimes, our student leaders and groups face discrimination and sometimes even violence on campus. Here are the stories of some courageous campus pro-life groups and how they overcame their challenges during the 2012-2013 school year.

JOHNS HOPKINS UNIVERSITY

In March, Johns Hopkins University's Voice for Life (VFL) group applied for official club status and was denied. In justifying their decision, the Student Government Association (SGA) informed the group that their plans for sidewalk counseling would constitute "harassment" under school policy. In addition, the group's website, which contained links to numerous national pro-life organizations, was "offensive."

Emails among members of the SGA compared the pro-life students to a white supremacist group at a nearby campus and called sidewalk counseling "hate speech." The leaked e-mail conversations also contained lines such as: "We have the right to protect our students from things that are uncomfortable... Why should people have to defend their beliefs on their way to class?"

After Students for Life took the story national, tensions on the Johns Hopkins campus were high, and the pro-life student came under intense scrutiny for calling out the injustice of the SGA decision. However, when the Voice for Life brought their appeal of SGA's decision to the Student Judiciary Council, armed with letters from SFLA lawyers, the original decision was overturned and Voice for Life was granted official club status!



UNIVERSITY OF CINCINNATI (UC)

After the UC Students for Life group brought the Genocide Awareness Project (GAP) to their campus this spring, they faced some unexpected results. UC's Lesbian, Gay, Bisexual, Transgender, and Queer Alliance and the UC Feminists responded by hosting an "art" display, "Re-envisioning the Female Body" to campus. This "art" display consisted of billboard sized photos of female genitalia. In addition to the vulgar photos, the pro-abortion groups scheduled a panel from Planned Parenthood to kick off this event.

So, the UC Students for Life group sprung into action - issuing a national press release and immediately responding to the lewd display with SFLA flyers exposing Planned Parenthood's corrupt business model.

Annmarie Condit, the Vice President of UC Students for Life, spoke eloquently: "We are deeply saddened by this response to our use of abortion pictures on campus. The abortion pictures, while shocking and offensive, display the truth about the humanity of the babies killed by abortion. Using objectifying images of women with the claim that it makes a political or artistic statement is an utter non-response to the important issue of abortion; it's nothing but the depraved use of obscenity for shock value."

Controversy on Campus...

UNIVERSITY AT BUFFALO (UB)

When the UB Students for Life group brought the Genocide Awareness Project (GAP) to campus this spring, one professor did not know how to restrain herself. She approached the pro-life students and began cursing that the display, calling it profane and saying it was "swearing" at her. She created such a scene that campus police had to arrest her disorderly conduct.

The next day, six UB history professors wrote a campus op-ed accusing our pro-life students of having a "crass, uninformed, and dangerous" view of history, in comparing abortion to the Holocaust and lynchings. Yet these same professors had no problem making a worse mistake: comparing our peaceful pro-lifer students to those who supported lynching.

Two days later, the pro-aborts had a chance to defend their position in a formal debate on campus. When they became overwhelmed by the pro-life argument, a student stood in the audience and invited them to "stand up and leave with dignity." The graduate and undergraduate proabortion debaters left, leaving the debate victory to the pro-life side!

UNIVERSITY OF WASHINGTON (UW)

When the University of Washington (UW) Students for Human Life group brought former abortionist/ now pro-life OB/GYN Dr. John Bruchalski to campus, they were a met with fierce opposition from pro-abortion students, who apparently were afraid of what the former abortionist might have to say.

The antagonism started before the event even happened: flyers were torn down or defaced. Altered versions of advertisements appeared on campus as pro-aborts made unpleasant changes and re-posted flyers. Next, they set up a Facebook group to organize a protest – which at least gave UW Students for Human Life a warning of what to expect. The pro-aborts prepared hand-outs and encouraged people to come to the protest dressed in black.

A male protestor led the chant outside of Dr. Bruchalski's presentation: "Pro-Life men have got to go! When you get pregnant let us know!"

However, in some ways, their protests backfired, and UW Students for Human Life used them to their advantage. Several students came to the event because the protesters made them curious; another student didn't know where to find the event until he heard the noise!

Outrageous Flyer Contest

We know that many of our students face unfriendly and even openly hostile environments on campus, which makes us admire their courage even more. In April, SFLA held a contest calling on our student groups to send us the most outrageous flyers they found on campus. We know our students see lewd, offensive, and inaccurate flyers all the time, and we wanted to see the best of the worst.

Our top prize went to Central Michigan University, where CMU's chapter of *VOX: Voices for Planned Parenthood* hosted a Sextival, featuring "Condom Races," "Where Have You Done It?", and other unmentionable events. **Our runner up was the University of Washington's** flyer for "Kink 101," a BDSM workshop, hosted by Sexual Assault and Relationship Violence Activists. This flyer could have won the "Irony" category, if only we had had one.

OUR LEADERSHIP TRAINING

Students for Life's mission goes beyond starting pro-life groups on college, high school, medical and law campuses. We train student leaders to continue to be leaders in the pro-life movement, on their campuses and in their communities, while in school and beyond. Our goal is to have trained pro-life activists nationwide who can be mobilized at a moment's notice for the day *Roe v. Wade* and *Doe v. Bolton* are overturned. To this end, we offer a variety of types of leadership training so that students can become bold and savvy leaders.

Our Regional Coordinators offer group trainings for campuses and one-on-one consultations for leaders of pro-life campus groups. During the 2012-2013 school year, SFLA Regional Coordinators held **367** consultations and **125** training sessions.

In addition to these consultations and trainings, we want our students to be in touch with the best pro-life leaders in the nation and in their communities. We accomplish this through our National Conference, Regional Conferences, year-long Fellowships, and summer Internship program. During the 2012-2013 school year, the SFLA team trained over **3,600** students.



Regional Conferences...

Because the students we serve are scattered across the country, Students for Life hosts several Regional Conferences throughout the year to bring our leadership and activism training and networking to them. We bring the best national and local pro-life leaders in different cities together for targeted training.

Every conference is specially designed to meet the needs and challenges of pro-life students in each region. Topics covered during the 2012-2013 school year included: Leadership, Campus Activism, Electing Pro-Life Candidates, Lobbying Policy and Legislation, Campus Recruiting, and Sidewalk Counseling.


In addition to trainings and networking opportunities with the broader pro-life movement, these conferences help to facilitate relationships and team building between pro-life students on different campuses.

Missionaries for Life..

Our highly competitive summer internship program, known as Missionaries for Life, selects the best and brightest pro-life college leaders from around the country and brings them to Washington, D.C. for a 9-week program involving three rotations – one in our national office, one on Capitol Hill with a pro-life member of Congress, and another in the office of another national pro-life organization. The internship is unpaid, but host homes are provided.

The goal of this one-of-a-kind program is to give aspiring pro-life leaders the opportunity to experience what it's like to work in the pro-life movement full-time, find their niche in this human rights cause, and obtain the skills and contacts they need for future success.





Wilberforce Leadership Fellowship...

Founded in 2010, Students for Life's Wilberforce Leadership Fellowship selects highly motivated prolife college leaders who are planning a career in the pro-life movement, matches them with a pro-life mentor, and trains them in the leadership principles they will need to become an effective leader in the pro-life movement. The intensive program requires participation in a 3-day summer training program, participation in bi-weekly conference calls, and regular mentor discussions.

As they graduate college and head into the workforce, our previous Wilberforce classes are a testament to the program's success. Anne Morse (Missionary for Life 2012 and Wilberforce 2012-2013) started working full-time for the Population Research Institute. Devyn Nelson (Wilberforce 2010-2011) has been recently named Executive Director of North Dakota Right to Life.

STUDENTS FOR LIFE IN ACTION

THE PLANNED PARENTHOOD PROJECT

On April 15th, 2013 Students for Life of America set out on a 2-week Bus Tour to expose Planned Parenthood's business model on college campuses. *The Planned Parenthood Project*, which will be expanding during the 2013-2014 school year, educates students on Planned Parenthood's real agenda and plans for them. The tour includes a display of **915** "**Planned Parenthood pink**" **crosses** to represent the 915 pre-born children killed by Planned Parenthood every day, with American tax-payer dollars. In addition, 4 large billboards are setup next to the crosses to walk students through Planned Parenthood's model and pro-life students on hand out educational postcards to passers-by.

The Spring 2013 Tour went to eight schools: University of Cincinnati, Franciscan University of Steubenville, Seton Hall University, American University, University of North Carolina-Chapel Hill, Clemson University, University of Alabama-Birmingham, and Tulane University.

This *Planned Parenthood Project* addresses a critical problem among 18-24 year olds. In a survey released by Students for Life in 2012, we found that young people had an overwhelmingly favorable view of Planned Parenthood and **59% of those surveyed said that Planned Parenthood didn't provide abortions or that they didn't know if they provided abortions!** However, we found that favorability towards Planned Parenthood was directly related to whether or not they knew the organization performed abortions. So the idea is simple: Show young people that Planned Parenthood is America's abortion goliath and they will lose credibility and favorability.

Make no mistake about it: Planned Parenthood is pushing their advantage among college students. A 2012 Students for Life study found that **78.8% of Planned Parenthood facilities are located within 5 miles of a college campus**. Planned Parenthood is targeting college students, but we are fighting back by exposing their role in the abortion industry. And they are noticing. Project Projec





During our Spring Tour, we ran into many proabortion protestors. However, at the University of North Carolina-Chapel Hill, proabortion students took their demonstration a little further -- posting lewd photos of themselves in front of our display, publicly thanking Planned Parenthood for aborting babies, and stealing a box of informational SFLA postcards and destroying hundreds of dollars worth of materials.

AUSTIN #STAND4LIFE BUS TOUR

In July 2013, events in Texas motivated one of SFLA's most successful activism events to date. When TX State Senator Wendy Davis filibustered and pro-aborts disrupted the democratic process to block the passage on a common-sense pro-life bill *that would ban* abortions after 20 weeks when babies can feel pain and force abortion facilities to adhere to basic safety standards, we knew we had to be there for the next special session.

We knew we had to be there to back up the pro-life majority in the TX Legislature and change the media narrative surrounding events as all of the national press were praising Senator Davis for her "heroic act." Despite the 4th of July holiday, summer vacations, and summer jobs, we decided to gather as many young people as we could to go down to Austin to *#Stand4Life*.

As we rallied students, it quickly became apparent that we would have too many people for a caravan. We needed a bus. And we needed homes for the 80 students we would have in the Texas capital during their second special session. Our national team threw itself into phone calls and fundraising, so that we could pay for a bus and house students in Texas. Our supporters across the nation responded heroically. Offers of houses, beds, and food poured in; along with the funding we needed for the trip. Local churches agreed to host us each night, although we would need to find somewhere else for our group to shower.

Early in the morning of Sunday, July 7th, the SFLA team boarded a bus – now wrapped in a pro-life banner for our Austin Bus Tour. We stopped in Roanoke (VA), Knoxville (KY), Nashville (TN), Memphis (TN), and Little Rock (AR), picking up more students at each stop. Finally, we arrived in Texas on Monday, after a 30-hour drive. There we met up with students from Texas and across the nation who had flown or driven on their own to join to #Stand4Life.

Once there, we met with Texas Lieutenant Governor Dewhurst to hear about the filibuster that kept the bill from being passed and the new push to ban abortion after 20 weeks. We joined the National #Stand4Life Rally at the Texas Capitol, where our own Missy Martinez (*National High School Program Coordinator*) represented the pro-life generation.

Monday night we were grateful to the local Austin YMCA for opening their showers to us. We sent in people a few at a time to shower quickly. But apparently, our pro-life t-shirts were too much for some pro-abortion gym patrons to handle. The next day, the YMCA called us to inform us that because some members did not like our views, we would no longer be able to shower there. We were shocked that a the "Christian" association would turn us away! However, when the story hit the national news, a local Catholic high school, despite the extra costs to open during the summertime, opened up its doors for us.

As the week went on, things really heated up in Texas. To be honest, our team had never witnessed anything like it. Each day, we stood peacefully in the Capital during pro-abort protests, showing support of pro-life law-makers and singing hymns to cover their chants of "Hail, Satan!" and demonic screaming. The vulgar and explicit signs (sometimes held by children) and the profane and crude chants (some of which got them arrested) were only the warm-up, however. Friday, we got to see just what the proabortion movement is made of.

As the bill was preparing to be passed into law on Friday night, orange-clad pro-aborts flooded the Capitol. Many of those in orange had urine, feces, paint, and bricks confiscated, so that they could not throw these at pro-lifers, as they had planned. The Department of Public Safety (DPS) decided it was no longer safe for pro-lifers (who were wearing blue) in the Capitol. The entire building went on lockdown.

Most of our group made it out safely, but soon proaborts began blocking corridors, leaving some of our team members and students trapped inside. Thankfully, TX Representative Bryan Hughes came to the rescue, sheltering us in his office. And guarded by DPS officers, we watched the end of the debate and the vote that won the day for Life!

OUR NATIONAL CONFERENCE

On January 26, 2013, for the fourth consecutive year, Students for Life hosted the largest pro-life conference in the nation. We filled registration with over 2,000 students from across the nation who came for a full day filled with workshops, presentations, and networking.

In addition to nationally acclaimed pro-lifers such as Scott Klusendorf (*Life Training Institute*), Jennifer Lahl (*The Center for Bioethics and Culture*), and Sue Thayer (*Alliance Defending Freedom, former Director of Planned Parenthood*), this year's conference featured the stars of MTV's "16 and Pregnant" reality show, Catelynn Lowell and Tyler Baltierra.

At the conference Students for Life honored several groups and individuals for their commendable work during the previous year.



Defender of Life Award

Students for Life presented our annual Defender of Life Award to **Father Frank Pavone**, National Director of Priests for Life. His groundbreaking work exposing the true horrors of abortion through images of the aborted child, countless hours outside of abortion facilities offering help to women, and great compassion for women and men with heartache from abortion have inspired a generation to enter into the pro-life movement.



NATIONAL CONFERENCE GROUP AWARDS

High School Group of the Year: Shanley Teens for Life (Fargo, ND)

Shanley Teens for Life brought 100 students this year to the March for Life and SFLA National Conference, offering their trip as a prayer for those harmed by abortion and for an end to the culture of death. Some of their most notable activities have included 24hour prayer vigils in front of abortion facilities and high profile speakers such David Bereit, 40 Days for Life.

Best New Group of the Year: Mizzou Students for Life from University of Missouri

Mizzou Students for Life brought the Genocide Awareness Project (GAP) to campus for their first-ever event. They also hosted Catelynn and Tyler, from MTV's reality show, "16 & Pregnant." This group has quickly become a staple of the local pro-life community and one of the most recognizable and influential organizations on their campus.

NATIONAL CONFERENCE GROUP AWARDS (cont.)

Runner-Up for Group of the Year: Hilltoppers for Life from Western Kentucky University

Last year Hilltoppers for Life hosted a *Life Week*, with a week's worth of activism and education. In the middle of one night, a student placed condoms over all the crosses in their *Cemetery of the Innocents* display. Because campus security refused stop her, SFLA and Hilltoppers for Life were able to bring national pressure on university officials forcing them to recognize the rights for pro-life students. Hilltoppers for Life followed up their *Life Week* by bringing *Created Equal* to campus, chalking pro-life messages every month, and hosting a 40 Days for Love campaign, to turn the tide of sexual immorality.

Group of the Year:

Students for Life from University of Michigan

Students for Life at UM has excelled as part of SFLA's *Pregnant on Campus Initiative,* raising almost \$3,000 for a local Pregnancy Resource Center and on-campus advertising, hosting a pregnancy resource drive and forum, and **running an ad campaign on the school's bus system which they know saved a life.** The group also brought the Genocide Awareness Project (GAP) to campus, debated the Secular Student Alliance, set up a *Cemetery of the Innocents* display, and ran a successful "I Vote Pro-Life First" campaign and rally with *Students for Life of America,* Jill Stanek, and *Rock for Life.*





EVERYDAY HERO AWARDS

In 2011, Students for Life lost two team members in a tragic car accident when they were hit by a drunk driver: our Field Director, Kortney Blythe Gordon, with her preborn daughter, Sophy, and our Pregnant on Campus Coordinator, Jon Scharfenberger. In their memory, the SFLA team created the Everyday Hero Awards. Our logo is one candle lighting another, a symbol of our mission to train and equip this generation of pro-life activists to become the leaders who will end abortion in our nation. Kortney and Jon lived their lives lighting candles in the darkness, which now shine brightly for the pro-life movement. We know that the candles they lit are burning strong – saving lives, lighting other candles, and changing our nation.

Our annual Everyday Heroes Awards serve not only to honor the memory of our dear friends and teammates, but also to thank those who are on the front-lines of this human rights struggle and inspire others to take action for Life.

2013 Kortney Blythe Gordon Everyday Hero Award Winner: Julie Beyel

Julie Beyel is the Director of Client Services for Care-Net of Central New York where she has personally saved the lives over 1,000 children through sidewalk counseling.

2013 Sophy Joy Gordon Everyday Hero Award Winner: Foster Friess

Once internationally known as a powerful investor, Foster Friess and his wife Lynn have given their lives to Christ and devoted their resources to others by supporting domestic mobile medical units, international water purification efforts, disaster relief aid, and many pro-life organizations, including pregnancy help centers.

2013 Jonathan Daniel Scharfenberger Everyday Hero Award Winner: Ben Clapper

Benjamin Clapper, a former SFL student leader, is now the Executive Director of the Louisiana Right to Life Federation, which works through education, activism, legislation, and service to restore the right to life in Louisiana.

MED STUDENTS FOR LIFE

Since 1973, one area left largely untouched by the prolife movement has been medical schools. Yet, from day one, pro-life students' beliefs are directly challenged in medical school. Without any real support for pro-life medical students, we risk losing future pro-life physicians as once pro-life students, for fear that their careers will suffer, acquiesce to the values set forth by their pro-abortion professors. Awareness of this danger led SFLA to launch Med Students for Life of America (MedSFLA) in the fall of 2010.

The vision and purpose of MedSFLA is to be a national network of future medical professionals committed to developing sustainable patient healthcare by advocating person-centered medicine. MedSFLA believes in rediscovering the patient-doctor relationship with care for every patient regardless of race, developmental stage, socioeconomic status, or special needs.

Our goal is to change the culture of medicine, one physician at a time, by making sure pro-life medical students graduate medical school and are placed in high-quality residency programs.

During the 2012-2013 school year, MedSFLA gained significant momentum --- starting **16** new groups, ending the year with **50** active MedSFLA groups nationwide. In addition to starting and equipping pro-life medical school groups, MedSFLA held National Fall and Spring SpeakingTours (visiting **36** medical schools), hosted **4** educational webcasts, and organized **4** Regional Conferences.

2012-2013 National Speaking Tours

During the 2012-2013 school year, MedSFLA traveled with Dr. John Bruchalski, Dr. Bill Toffler, Dr. Reg Finger, Dr. Angela Lanfranchi, Dr. Clem Persaud, Dr. Anita Showalter, Dr. Marguerite Duane, Dr. Stephen McCurdy, Dr. John Seeds, and Dr. Byron Calhoun. Together, they visited **36** medical school campuses reaching over **4,000** future doctors with the pro-life message. We covered topics such as assisted suicide, natural family planning, the abortion breast cancer link, practicing as a pro-life OB/GYN, epigenetic technology, perinatal hospice, autonomy and high-risk pregnancies.

2013 Summer Externship

This June, MedSFLA launched our 2nd Summer Externship at Princeton University for a week-long medical ethics training by some of the top pro-life medical ethicists in the nation. Medical students selected to participate in the 2013 MedSFLA's Summer Fellowship learned about the Hippocratic Oath, natural law as it pertains to medical ethics, care of patients at the end of life, and moral concepts that make up the doctor-patient relationship.

After the medical students completed their one-week seminar, they returned to their communities to volunteer at pregnancy resource centers and participate in clinical rotations with local, pro-life physicians. Throughout the summer, our MedSFLA Externs wrote research papers on various topics pertaining to pro-life medicine. Since the conclusion of their research and externship, MedSFLA has begun assisting the students in publishing their research in medical journals.

These medical students are the rising stars of the prolife movement as many of them will go on to serve on medical boards and teach academic medicine. It's our vision that they will change the pro-abortion medical culture from the inside out.



During the Fall of 2012, our team at Students for Life took on a new mission, the *I Vote Pro-Life First Initiative*. Making SFLA the only national pro-life group organizing at the grassroots level for voter education during the presidential election cycle.

We launched our initiative with campus tour in September, featuring pro-life blogger and former nurse, Jill Stanek. The tour visited the University of Michigan, Michigan State University, Purdue University, Indiana University-Purdue University at Fort Wayne, University of Cincinnati, University of Akron, Clarion University, and Franciscan University.

As the election approached, SFLA partnered with other national organizations in a *Get the Vote Out* (GOTV) campaign. Over **83** student groups joined our efforts, participating in phone banks and door-knocking to contact voters urging them to only vote for pro-life politicians. By election day, our students and full-time team had contacted over **439,000** voters!



STOPCARHART.COM

In February 2013, a young mother and her pre-born daughter died as a result of a third trimester abortion performed by abortionist LeRoy Carhart in his Maryland facility. Sadly, Carhart operates one of the few facilities in America that will perform late term abortions.

Responding to this tragedy, Students for Life said, "Never again." Joining with Operation Rescue, Live Action, JillStanek.com, LifeSiteNews.com, Survivors of the Abortion Holocaust, and Rock for Life, we launched a coalition website to gather citizen complaints against Carhart to bring to the Maryland Board of Physicians. Through our website, StopCarhart.com, we gathered more than 5,000 letters from citizens who demanded that the board conduct a thorough investigation into Carhart's abortion business and that his license be immediately suspended.

When we first tried to deliver the complaints, the Maryland Board of Physician refused to accept the letters that we delivered. A few weeks, we tried again, and this time they agreed to take the complaints. We gathered an additional 1,000 more complaints during the delay, and citizens continued to swarm their office with phone calls and emails.

NOTATBC.COM

This spring, Boston College, a Catholic university, invited Irish Prime Minister Enda Kenny to speak at its commencement, in spite of the prime minister's public support for legalizing abortion in Ireland. In response, Students for Life called pro-lifers across the world to use the website NotatBC.com to tell Boston College's president, Rev. William Leahy, to rescind the invitation.

Even though Rev. Leahy refused to revoke his invitation, we saw success when Cardinal Sean O'Malley, Archbishop of Boston, announced that he would not attend the graduation.

However, we didn't stop there. The SFLA team traveled to Boston to lead a prayer vigil and pro-life witness outside of the commencement.

A few weeks later in Washington, D.C, our team was at it again when we held a pro-life vigil at the Irish Embassy, in solidarity with the National Pro-Life Rally happening that day in Dublin, Ireland.




RELEASE OF OUR FIRST BOOK: COURAGEOUS


Social media not only represents a free way to get Students for Life's name and mission into the public discourse, but it also gives us a huge opportunity to educate and active our college and high school students where they are: online.

WHERE WE ARE GOING


Seven years ago, the grassroots, pro-life movement was in decline. At pro-life lobby days, marches, and community events, seeing students was a novelty. Today, it's the norm. Young people, now more than ever, consider themselves pro-life.

Students for Life of America's one-of-a-kind Field Program has played a pivotal role in the revival and expansion of the grassroots pro-life movement over the past 7 years, growing the number of pro-life student pro-life groups from 181 in 2006 to over 750 today. Because the majority of abortions are performed on college-aged women and 79% of Planned Parenthood facilities are located within 5 miles of a college campus, our full-time Regional Coordinators are identifying, training, and leading the ground troops in the abortion battlefield in America, college and high school campuses.

However, as our program has grown, our demand has far outpaced our resources. With so many gaps across the country, we are not able to provide the crucial support needed to hundreds of student groups and organizing these groups for state referendums and national election efforts has become an increasingly difficult pipedream. Currently, Students for Life has 6 full-time Regional Coordinators covering WA, OR, ID, MT, AK, CA, NV, AZ, NY, NJ, KY, UT, NM, CO, WY, TN, MI, IN, OH and 3 Support Team Members. We have an immediate need to hire 9 additional Regional Coordinators and 4 new Support Team Members to cover the nation --- bringing our total to 15 Regional Coordinators and 7 Support Team Members, completing the first phase of our long-term expansion plan.

This expansion opportunity will allow Students for Life to become the only pro-life organization in America with trained staff positioned in each geographic region, with the largest number of trained, grassroots activists, not just e-mail supporters, who are ready to abolish abortion in this lifetime. With so many important battles coming in our near future, we know this is an investment we must make now.

For the past 7 years, we have learned the best tactics to educate, inspire, and mobilize this generation. Our past supporters in our mission have continued to support our work and trust that the metrics we set out to achieve are reached. We hope you will consider partnering with us in building the next phase of the grassroots pro-life movement.


